## **1. LEGAL NOTICE AND IDENTIFICATION OF THE RESPONSIBLE COMPANY**

The promotional action called "**DOUBLING YOUR BET (FINAL CHAMPIONS)**", consists of a promotion under the format of signing up on a **SHEET** and is organized by the company **SPORTIUM APUESTAS ANDALUCÍA SLU** (hereinafter, "**SPORTIUM**" or the "**Company**") a company incorporated in accordance with Spanish regulations, with registered office in **Malaga, at Avenida Los Vegas, nº 27, C.P. 29006** and holder of CIF number **B93531606**.

**SPORTIUM** is the holder of the necessary gaming licences to be able to carry out its activity as a gambling operator in the Autonomous Community of **ANDALUSIA**. In the development of its activity as a provider of gambling and betting services (hereinafter jointly referred to as the "**Gaming Services**"), **SPORTIUM** acts under the supervision and control of the gaming regulatory body of the aforementioned Autonomous Community, in accordance with the current regional regulations applicable to gaming and betting.

The provision of gaming services developed by **SPORTIUM** in the Autonomous Community of **ANDALUSIA** is subject to a prior administrative authorisation regime, consisting of a gaming licence.

**SPORTIUM** is the company responsible for the "**DOUBLING YOUR BET (FINAL CHAMPIONS)**" **SHEET (HEREINAFTER, THE "PROMOTION")**. **SPORTIUM** has the necessary administrative authorisations both in terms of gambling, consumption and retail trade to carry out this promotional action or, where appropriate, has previously notified the corresponding public administrations of the carrying out of the **PROMOTION**.

## **2. PURPOSE OF THE LEGAL BASES**

The purpose of these general terms and conditions of participation in the PROMOTION (hereinafter, the "**Legal Bases**") is to regulate the conditions under which Sportium customers may participate in the PROMOTION, subject to acceptance of the same and, if they meet the requirements and mechanics of participation, benefit, where appropriate, from the Prize.

These Terms and Conditions have been drafted in accordance with the provisions of the applicable regulations in force on gambling, consumer and user protection and data protection. SPORTIUM customers who participate in the PROMOTION (hereinafter, the "**Participants**") may find these Terms and Conditions available to them at any of the SPORTIUM premises in the territorial area of the PROMOTION, entitled "**WE DOUBLE YOUR BET (FINAL CHAMPIONS)**", where they can participate in said promotional action so that they can consult them at any time and whenever they want during the Promotion Period. ### **3. TERRITORIAL SCOPE**

The territorial scope of the DRAW and, therefore, the territorial scope where these Legal Terms and Conditions will be applicable (hereinafter, the "Territory"), at the following Sportium point of sale:

### **4. REQUIREMENTS TO PARTICIPATE**

Participation in the PROMOTION is fully voluntary, free of charge and at no additional cost to the Participants. Participation in the PROMOTION entails the full, full and unreserved acceptance of these Terms and Conditions. Failure by the participant to comply with any of the Legal Terms and Conditions implies the implicit waiver of their participation.

Persons who comply with the provisions of these Terms and Conditions and meet all the requirements specified below may participate in the PROMOTION:

- 1) be over 18 years of age;
  - 2) have their legal domicile in Spain;
  - 3) not be self-excluded as they are registered in the General Registry of Prohibition of Access to Gambling (RGIAJ) or registry of prohibited access to gambling of the corresponding Autonomous Community;
  - 4) **be the holder of a Sportium settled bet ticket of at least 5 euros placed within the participation period, in the territory, and sign up on the sheet located in the premises with their personal details (name, telephone number, barcode, prediction and signature).**
  - 5) accept these Terms and Conditions, which are understood to be fully accepted by participation in this PROMOTION.
- 6) For the purposes of the PROMOTION, the following is understood:
- "Account" means the user account associated with a personal Sportium wallet card through which a SPORTIUM customer can place bets at SPORTIUM betting venues.
  - "Bet": gambling activity in which an amount of money is risked on the results of a previously determined event, with an uncertain outcome and beyond the control of the parties involved in it.
  - "Formalise": validly placing a bet in accordance with the provisions of the "Glossary of Terms" contained in the "Sportium Betting Organisation and Operation Rules".

Any other terms specific to betting and/or the PROMOTION that appear in the Legal Terms and Conditions must be interpreted according to the definition of said term contained in the "Glossary of Terms" contained in the "Sportium Betting Organisation and Operation Rules".

SPORTIUM will only contact the Participants by telephone call made only to the telephone number they have designated when depositing their **settled bet tickets of at least €5 on the sheet**, as participants in the draw. Therefore, it is of vital importance that the Participants enter correctly, completely and accurately their contact telephone number, which must be the real and proper number of each of the Participants.

Participants who do not meet all the aforementioned requirements, especially those who fail to comply with their obligation to enter their telephone number correctly, completely and accurately, will not be able to participate in the PROMOTION nor will they be able to obtain the Prize. Therefore, all those Participants who do not meet all the requirements established in these Legal Terms and Conditions will be discarded by SPORTIUM automatically and without the right to any compensation or compensation.

The following are **expressly excluded from participation** in the PROMOTION, and therefore their participation in it is prohibited: (i) all employees of SPORTIUM; (ii) persons who maintain a commercial relationship with SPORTIUM (including partners and investors); (iii) spouses, ascendants, descendants and other relatives by consanguinity or affinity up to and including the 2nd degree of all the above; (iv) the companies to which SPORTIUM may entrust the management and/or organisation of this promotional action; (v) employees of the latter (regardless of the employment or commercial nature of their relationship); and (vi) any other person who is prohibited from accessing the gaming premises and/or participating in gambling in accordance with the current regional regulations applicable to gaming and betting.

## **5. MECHANICS OF PARTICIPATION**

To participate in the PROMOTION, each Participant must:

- 1°** Place a bet of at least €5 in Sportium, on the dates of participation in the PROMOTION and in the premises described as the Territory.
- 2°** Once the bet has been settled, give it to the Casino staff so that they can write the personal data (name, telephone number, barcode, prediction and signature) on the validation sheet
- 3°** Provided that the client complies with all the requirements described in these rules, he/she will become part of the database of participants for the draw, the process of which is specified in point 8 of these legal bases.

Each Participant may only participate in the PROMOTION once with the requirements specified in these rules.

## **6. PARTICIPATION PERIOD**

**The deadline to participate in the PROMOTION begins on May 21, 2026 at 11:00 a.m. and ends on May 30, 2026 at 3:59 p.m., both dates included.**

SPORTIUM reserves the right to declare void, extend the participation period, terminate early or suspend the PROMOTION at its sole discretion and without the right to any compensation or compensation in favour of the participants, especially in the event of force majeure or fortuitous event. In such a case, SPORTIUM will inform the Participants of this circumstance.

## **7. PRIZE IDENTIFICATION**

The PROMOTION consists of doubling the amount in freebets of the bet registered on the sheet if the customer guesses the correct score of the Champions League 2026 final.

## **8. HOW TO GET THE PRIZE**

Once the period of participation in the draw has ended, Sportium will proceed to review the different predictions of the customers and will make a telephone call to the winners at the number they have indicated.

Once the draw has been made, the prize will be communicated to the lucky person. In case of acceptance, the amount of the freebets will be charged to the customer's card.

Therefore, the beneficiary of the draw prize will be the participant who registers and correctly predicts the correct score in the Champions League 2026 final (90 minutes) after the review that will be **carried out on Monday, June 1, 2026** and who confirms the acceptance of the prize, provided that it fully complies with the provisions of these Legal Bases, especially with regard to the requirements, the mechanics of participation, and the period of participation of the PROMOTION (hereinafter, "the **Beneficiary(s)**").

During the period of participation, SPORTIUM will review compliance with the requirements and mechanics of participation and the acceptance of the Legal Terms and Conditions by the Participants, automatically excluding all those who fail in any way to comply with the provisions of these Terms and Conditions and those with whom SPORTIUM cannot contact because they have entered a false telephone number. incorrect, incomplete, or owned by a third party.

In the event that the Participant meets all the requirements and mechanics of participation, as stipulated in these Legal Bases, he/she will become part of the database of participants in the draw.

In any case, SPORTIUM reserves the right to leave the Prize void for reasons of force majeure or justified causes, as well as in the event that the Participants do not comply with the provisions of these Legal Terms and Conditions or participate in any way fraudulently in the promotion and/or in breach of these Terms and Conditions.

## **9. LIMITATIONS ON OBTAINING THE PRIZE**

Only customers who correctly deposit their prediction on the sheet for this purpose, located in the premises within the dates of participation in the PROMOTION, may participate in the draw to obtain a prize.

In the event that SPORTIUM is unable to deliver the gift to the beneficiaries of the same due to force majeure, it will inform the latter of this circumstance and provide them with a substitute gift of at least similar characteristics, of the same value. SPORTIUM reserves the right to declare the gift void.

## 10. CONDITIONS AND LIMITATIONS OF ENJOYMENT OF THE PRIZE

The PROMOTION Prize will be delivered to the beneficiary via Sportium freebets on the Thursday following the acceptance of the prize.

In no case will the delivery of the Prize entail the obligation to purchase any product or contract any service. The renunciation of the Prize will not entitle the Beneficiary to any compensation or compensation.

## 11. FRAUDULENT PARTICIPATION. SPORTIUM'S INSPECTION POWER.

SPORTIUM reserves all the powers and actions necessary to verify the veracity and adequacy of the participation and actions of the Participants in the PROMOTION to these Legal Terms and Conditions (including, for non-limiting exemplifying purposes only, requesting a copy of the National Identity Document or equivalent identification document) and to investigate any action of any Participant suspected of fraud or contravention of the provisions of the these Terms and Conditions, good faith or applicable law.

SPORTIUM may automatically exclude from the PROMOTION, without prior notice and without any right to compensation or compensation, any Participant, including the Beneficiaries, who fails to comply with the provisions of these Legal Bases, applicable legislation and good faith (especially in the case of multiple participation or introduction of false, incorrect, incomplete or third party personal data) or who suspects any irregular action or action, reserving the exercise of any actions that may be appropriate for the compensation of the damages caused.

## 12. DATA PROTECTION AND IMAGE RIGHTS

### **14. LIABILITY REGIME**

The Participants are solely responsible for any damages that may arise for SPORTIUM and/or for third parties as a result of the failure to comply with the obligation to provide SPORTIUM with their personal data in an updated, truthful, accurate and complete manner and corresponding to their own identity (and not that of third parties) at the time they provide them.

In no case and under no circumstances will SPORTIUM be liable for any damages, whatever their nature (for non-limiting illustrative purposes only: direct, indirect, circumstantial, temporary or indefinite) and/or amount that may be caused to participants or third parties as a result of participation in the PROMOTION and/or the enjoyment of the Prize.

SPORTIUM is not responsible for damages arising from any failure, problem, action or omission by third parties unrelated to SPORTIUM, such as but not limited to, computer attacks, strikes, any type of civil revolt or threat, fires, floods, earthquakes or any other natural disaster, etc.

Any matter arising from or related to the incorrect, incomplete or inaccurate entry of their personal data or false data by the participants in the PROMOTION will be the sole and exclusive responsibility of the latter.

The headings contained in these Terms and Conditions are merely indicative or informative, so that they do not affect, qualify or expand the interpretation of the same.

In the event that any of the clauses contained in these Terms and Conditions is declared null, abusive or inapplicable, in whole or in part, by a judicial or administrative body, such declaration

will affect the clause in question individually, and it will be deemed not to have been put in place and without the declaration of nullity, abuse or inapplicability being extended under any circumstances to the rest of the terms of these Terms and Conditions. that will survive.

These Terms and Conditions are governed by the Spanish regulations in force at all times.

## **16. DISPUTE RESOLUTION AND APPLICABLE JURISDICTION**

A maximum period for receipt of complaints in relation to the PROMOTION is established. Thus, SPORTIUM will only process those claims related to said promotional action received within the month following the one in which the Participant made his/her Prediction. After this period, SPORTIUM will not attend to any claim related to the PROMOTION.

The Participants in the PROMOTION, including the beneficiaries of the Prize, expressly waive any jurisdiction that may correspond to them by law and expressly agree to submit any claim, controversy or litigious matter relating to or related to the PROMOTION to the Courts and Tribunals of the city of Cádiz.
